


Cedars All,

#### Naomi



Naomi was born July 14, 2009 to our already little family of three. We had some issues with decreased fetal movement during the pregnancy, but otherwise she came out a big eyed, smiley little elf. We were doing so well post c-section they talked about an early discharge, until the neonatal pediatrician came to talk to us. They wanted to keep Naomi for another day or so because they believed she had bilateral hip dysplasia and would need leg bracing. They finally sent us home though and had us return for a hip ultrasound when she was two weeks old, which she passed with flying colors. We didn't know that the first two signs of her disease just went over all our heads.

Naomi took her first steps a week after her first birthday. She got around pretty well, but she fell an awful lot. So much so that we mentioned it to her pediatrician at her 18-month check, again at her two-year-old check, and yet again at her 3-year-old check. We were told that toddlers "toddle, that's why they're called toddlers", that Naomi was perfectly fine and would stop being so "klutzy" one day. We trusted what they had to say, but always felt deep down that something wasn't right.

In July of 2013, just before her fourth birthday, we signed Naomi up for ballet. During her recital, we all realized there was something wrong with Naomi. She was now not only falling all the time, she couldn't get up off the floor, stairs were hard for her, and she couldn't hop or skip. We watched her pediatrician, who had been taking care of Naomi her entire life, turn

gray after observing her and turn to tell us that "I think Naomi has Muscular Dystrophy." We were sent to CHOP to see a Neuromuscular Specialist and a year later after countless appointments, tests, false leads, a muscle biopsy and finally a full DNA panel she was diagnosed with Bethlem/Ullrichs Myopathy, a rare form of Muscular Dystrophy. It's a progressive disease, and each year we see her strength wane and her abilities become fewer and fewer. Naomi utilizes a power wheel-chair if she needs to walk longer than a few minutes, stairs are impossible and she needs help with all the little daily tasks we all take for granted. She wears day and night leg braces, uses a chair lift to access the stairs and has a hospital bed to elevate her at night. Her type of MD affects the lungs, so we have to be vigilant for sleep apnea and anytime she's ill it's all hands-on deck with round the clock nebulizer and cough assist treatments that clear her lungs of fluid to keep her out of the hospital.

Naomi doesn't let any of this get her down. Although her body may fail her, she's just like any other 11-year-old girl. She is the middle sibling of two sisters and loves to tease them, but also loves them fiercely and would defend them with all her might. She loves playing with her baby cousins, reading, watching Anime, painting and playing video games on her Nintendo Switch. Naomi also has two dogs, a cat, a Conure parrot and 24 chickens! She goes to public school, has some very close friends who don't see her disability, participates in Student Council and gets into plenty of mischief. She is also an ambassador for the MDA and works side by side with the Harley Owners Group of Williams Harley Davidson in Lebanon NJ to spread awareness for Muscular Dystrophy. She gets to participate in the Ride for Life annual event along side other MDA ambassadors where the Harley owners raise money for research for a cure. Naomi is also the inspiration for "Team Naomi" and every year we raise money for the MDA in the annual walk. Her most favorite thing is to go to MDA Camp where she gets to be with other kids just like her. She has told us it's a week where she can forget that she's not a "regular kid". Her favorite camp activities are arts and crafts, swimming, and fishing, but mostly she loves being with the lifelong friends she's made there. Naomi dreams of one day becoming a Graphic Designer, although she'd probably make a good writer as she comes up with some pretty amazing stories! No matter what, we are sure that Naomi will make her mark in some way on this earth and that no place will be dull and boring with her around.

#### **Manchester Road Race**

An article in Journal Inquirer (Manchester Connecticut local newspaper) about donations associated with the Manchester Road Race. Although the road race had to be canceled for the 2020 Thanksgiving Road Race, by the generosity of the race sponsors, MDA in Connecticut will receive \$10,000.00 this month. Generally MDA receives \$20,000.00 per year but as the 2020 road race had to be canceled, we are so lucky to get this donation.

Let's hope this coming Thanksgiving the Road Race will be able to be held once again.

The Road Race was started (after a period of years) By Nutmeg Forest #116 in 1945. The race brings about 15,000 runners from all over the world and Olympic runners each year. This year they held a "virtual" road race that had 2,000 registered runners.

I think this is fantastic considering the circumstances!

# Road race donates \$40,000

MANCHESTER — Although the Manchester Road Race wasn't held in its traditional format last year, the organizing committee continued the practice of making donations to local nonprofit organizations.

The committee announced that it will donated a total of \$40,000 to four organizations this month:

• \$20,000 to the Manchester Area Conference of Churches food pantry to combat food insecurity in the community that has been exacerbated by the pandemic and its resultant economic impact.

• \$10,000 to the Muscular Dystrophy Association to support its research efforts. The fight against the crippling childhood disease has been a primary charitable objective of MRR sponsors since the early 1950s.

• \$5,000 to the Manchester Police Activities League.

• \$5,000 to Dinda House, a transitional living facility for veterans that is located in Manchester.

"We are able to make these contributions thanks to the tremendous generosity of our financial sponsors and virtual road race entrants," said Dr. Tris president of Carta, Manchester Road Race Committee. "Because of the devastating economic conditions caused by the pandemic, the race committee believed that it was imperative to provide whatever financial support we could this year."

The principal financial spon-

sors of the 2020 Virtual Manchester Road Race were Pratt & Whitney and Eastern Connecticut Health Network.

Carta noted that the committee also sponsored a highly successful blood drive in conjunction with the Connecticut Chapter of American Red Cross on the day after Thanksgiving. A total of 306 pints of blood were collected, which will help 918 hospital patients in need of blood, plasma, and platelets.

Officials canceled the traditional Turkey Day run because of the COVID-19 pandemic—the first time since 1945 that the annual holiday race was not held in Manchester on Thanksgiving morning.

The committee held a virtual road race instead, which attracted approximately 2,000 registered runners who used the MRR's proprietary app on their smartphones while they ran the 4.748-mile distance at locations throughout Connecticut, the United States, and in several foreign countries during the week prior to Thanksgiving


Carta said that the committee will begin planning for November's 85th annual MRR shortly

"We will be consulting soon with officials from the state and the Town of Manchester and will make an announcement as soon as we feasibly can," Carta said. "Public health and safety will be our only concern, but we are obviously hoping and praying that we'll be able to hold the road race on Main Street on Thanksgiving morning."

# A Mental Health Moment Pandemic Fatigue Michael Johnstone, Senior Deputy Neptune Forrest

As the pandemic continues and Mental Health Month upon us, I felt it fitting with being your mental health professional to share some tips with coping with our health crisis. We are in month 14 of the COVID-19 outbreak and has radically altered nearly every aspect of our daily lives. Social distancing, face covering, cleaning measures, and other restrictions have directly impacted each and every one of us. The way we interact, meet, dine, and function has been dictated and modified as health consideration changed. Quite frankly it has become exhausting and frustrating. Exhausting because the restrictions continues and change frequently. Frustrating to keep up with these changes and efforts to find a sense of normalcy. These feelings have led many people into Pandemic Fatigue. Pandemic Fatigue can be viewed as wrestling with intense emotions day after day which drains your energy and causes changes in normal routine. Fatigue can stem from a number of emotions during this pandemic to include:

- Fear
- Anxiety
- Loneliness
- Hopelessness

#### Signs of Pandemic Fatigues

One significant sign of fatigue is a sense of inner weariness. You may feel any of the following:

- Helplessness
- Sadness
- Worry
- Frustration
- Irritability

#### You may notice the following symptoms:

- Significant changes in appetite and/or sleep. This could include eating or sleeping more or less than usual.
- Trouble focusing, completing tasks, or getting distracted easily.
- Feeling nervous, restless, edgy
- Feeling irritable, snapping or arguing with people, quick to anger.
- Lack of motivation.
- Racing thoughts or unable to control thoughts.
- Withdrawing from others.

#### Here are seven healthy ways to cope with Pandemic Fatigue:

- Take care of your body. It is easy to get wrapped up in other concerns, news events, family, and the like. It is even easier to forget taking care of oneself. Ensure that you get enough sleep and eat meals on a regular schedule. Some form of exercise like swimming, walking, dancing, and similar are important as well.
- Limit your news intake. The news outlets are available 24 hours a day and it is easy to overload yourself which causes negative emotions, drain your energy, and increase stress. The TV, radio, and cell phone all have off buttons, use it.
- Lower your stress lever. Focus on activities that are calming and things that are enjoyable. Consider the following:
- Breathing exercises
- Yoga
- Medication
- Nature walks
- Reading
- Cooking
- Listening to music
- Connect with others. We as human beings are social creatures and desire social interaction. Consider making phone
  calls, video chats, online classes, and online religious services. Seeking social interaction while limiting physical
  contact.
- Accept your feelings. Challenging situation stir up mixed emotions. Ignoring your feelings can cause more stress. Acknowledge your feelings and allow yourself to have them.
- Seek positive self-talk. Fear and anxiety can lead to negative thoughts. Seek to replace the negative thought with positive statements. Replace thoughts of acquiring COVID-19 with thoughts of how I can remain safe.
- Finally, create new traditions. Create new routines, joyful times, and traditions such as creating time for family visits, self-care, and/or activities. Focus on existing hobbies, create a new hobby, home projects, or something that makes you feel good.

Pandemic Fatigue is a serious social concern and requires your attention. Now more than ever self-care should be your focus to help yourself and care for others in your immediate circle. Seek the assistance of a mental health or primary care provider as needed.

#### ARTICLE I—APPOINTED OFFICERS AND DUTIES

- F. Supreme Historian shall:
  - 1. gather all important historical data relating to the Tall Cedars of Lebanon of North America International and, from time to time, prepare the same in permanent form to be kept in the Archives of the Supreme Forest.
- H. Supreme Chief Clown shall:
  - 1. encourage Constituent Forests to organize and develop Clown Units.
  - 2. annually conduct and supervise such regional and national competitions as are necessary to determine national champions of the Tall Cedars of North America International individual and Forest classifications.

Tall Cedar Week shall be observed during that week in which the 18th day of March occurs, and each Constituent Forest should endeavor to promote and sponsor activities throughout the entire week to enhance the Fun, Frolic, and Fellowship, and propagation of the Tall Cedars of Lebanon of North America International.

#### G. Miscellaneous Provisions

- 4. Participation in Public or Private Affairs
  - a. No Constituent Forest, officer or member of Tall Cedars of Lebanon of North America International, shall parade, or participate in any public or private demonstration, either in civilian clothes or uniform, without written dispensation from the District Deputy Supreme Tall Cedar. The foregoing, however, shall not apply to any Tall Cedar's attendance at or participation in church services.

#### SUPREME FOREST CONSTITUTION





#### **Tournament Rules**

- 1. Tournament will be conducted according to rules governing tournaments of the United States Bowling Congress, and all participants must agree to be so governed.
- 2. Any applicant who has been refused membership in the United States Bowling Congress for good and sufficient reason is not eligible to participate.
- 3. Teams may be made up of 4 Tall Cedars, or 3 Tall Cedars and 1 Master Mason/DeMolay, or 2 Tall Cedars and 2 Master Masons/DeMolay. Each bowler must be certified as a member in good standing by the scribe of the entrant's Forest. An entrant who is unable to bowl may be replaced by a qualified Tall Cedar in accordance with USBC regulations and these rules. Youth bowlers may not receive cash prizes however gift cards will be substituted.

#### 4. Beginning 2020 Cedarettes, Jobs Daughters and Masonic Youth are encouraged to register for this event.

- 5. A bowler may bowl only once in each event.
- 6. All who bowl doubles must bowl singes and vice versa
- 7. Starting lanes and times will be assigned by tournament officials. All entries must bowl on lanes and at times assigned by these officers.
- 8. Tournament will be operated on a handicap basis of 90% of the difference between the individual average and 230 scratch.
- 9. A bowler's average as of January 1, 2020, must be for a total of twenty-one (21) games or more. If less than twenty-one games in a league, a bowler can add two or more leagues together to total the twenty-one games. Bowlers in more than one league must use the highest league average.
  - Average shall be certified by each entrant's league secretary.
  - Any bowler not having a league average shall be assigned an average commensurate with his ability, but not less than 150.
  - Bowlers who do not have a league average and have bowled in the Supreme Forest Bowling Tournaments, will be assigned an average compiled by averaging the last three (3) years bowled in a Supreme Forest Bowling Tournament.
- 10. Any bowler who reports a lower average than required, which changes his handicap classification, or who fails to report a prize of \$300.00 or more in any event in a tournament which has ended within the previous 12 month period, shall forfeit tournament entry fees and handicap prize winnings, Failure to use proper average, or to make corrections prior to completion of the first game of a series: Shall disqualify if submitted average is lower than actual average, or prize winnings will be based on submitted average if it is higher.
- 11. Tentative schedule of events (subject to change as required to accommodate all entrants):

Saturday 10:00 AM - 1:30 PM - Team, Doubles and Singles events

Sunday 9:00 AM - 1:00 PM - Team, Doubles and Singles events

- 12. Each team will indicate on entry blank preferred time for bowling. Entries from distant points will be given preference as to time whenever possible. Minor events must bowl both doubles and singles.
- 13. All captains must report one hour before bowling.
- 14. All individuals must report prior to bowling the doubles event.
- 15. Teams must bowl in the order names are listed on entry blank. Substitutions may be made (see rule 3), but entry blank will not be processed without team listing, including doubles and singles.
- 16. Tournament committee reserves all rights to govern this event.
- 17. An appeal or protest must be brought to the attention of the Tournament Manager within 24 hours.
- 18. Entries must be received by **April 10th**, **2020**.


